Hi Stacey,

This summer I sent you an email informing you that the Midwest MLA Chapter Board had decided to change how it appointed members to the State Liaisons Committee. This is a follow-up email to ensure that you received that information.

Until recently, each State Liaison was selected by the respective state health sciences association president. Following year's Annual Meeting, the process for selection and appointment will change to one that conforms with other Midwest MLA standing committees. That is, committee members will be drawn from current Midwest MLA members who have expressed interest on serving as a liaison between the Chapter and the state association. The Board hopes that this will encourage greater interaction and participation by committee members. The expectation is that the State Liaisons will be current active members in the state associations.
