July 29, 2022

The good news is that HSLI's tax exempt status has been reinstated with the effective date of exemption retroactive to our date of revocation. Many thanks to Geoff Pettys who was the impetus in getting the process started, and especially to Laura Wimmer, who not only agreed to take over treasurer duties again but worked diligently with the accountants at ATA Group to get this done. Moving forward we will continue to use a CPA to ensure the proper paperwork is completed each year so that this does not happen again.

Now that the tax-exempt issues have been resolved, we can restart the task force for the Jira Scholarship Fund to determine how to market the scholarship, develop an application process, and set the amount of the initial award.

The 2022 Conference Committee decided to hold the conference virtually again this year. It is scheduled for September 7-9. The contract with Starved Rock Lodge & Conference Center was cancelled in due time and we received a refund on our deposit.

Thank you to Peggy Carey and Frances Drone-Silvers of the conference committee who decided to start a HSLI Journal Club. To date, two meetings have taken place — one in March and one in June.

We still need to solicit ideas for a new HSLI logo.

#### Bills and other legislative items

- House Bill 4005 FOIA-RESPONSE-FORMAT OF DATA "Amends the Freedom of Information Act. Provides that a public body shall take all reasonable steps to provide records in a format that is readable by the requester, including, but not limited to, making the record available in any format that is available to the public body and requested by the requester. Effective immediately." (<a href="https://legiscan.com/IL/bill/HB4005/2021">https://legiscan.com/IL/bill/HB4005/2021</a>) – Filed 3/1/21; Re-referred to Rules Committee 2/18/22.
- House Bill 4259 INS CODE HEALTH CARE EXPENSES "Amends the Illinois Insurance Code. Provides that a group or individual policy of accident and health insurance that is amended, delivered, issued, or renewed on or after January 1, 2023 shall provide that a person who is eligible to receive a COVID-19 vaccine and chooses not to be vaccinated shall pay for health care expenses out-of-pocket if the person becomes hospitalized because of COVID-19 symptoms."

- House Bill 4263 INS PROHIBITED DISCRIMINATION "Amends the Illinois Insurance Code.
   Provides that no company, in any policy of accident or health insurance issued in the State, shall make or permit any distinction or discrimination against an individual solely because of the individual's vaccination status in the amount of payment of premiums or rates charged for policies of insurance, in the amount of any dividends or other benefits payable thereon, or in any other terms and conditions of the contract it makes. Provides that no company, in any policy of accident or health insurance issued in the State, shall refuse to insure or refuse to continue to insure an individual solely because of the individual's vaccination status."

- House Bill 4470 / Senate Bill 3167 ACCESS ELECTRONIC LITERATURE "Creates the Equitable Access to Electronic Literature Act. Provides that any publisher who offers a contract or license for electronic literary product acquisition to the public shall offer to license the electronic literary product to libraries, if purchased with public funds, on reasonable terms and under reasonable technological protection measures that will permit libraries to provide their patrons with access to the electronic literary products. Provides that a contract or license shall not restrict a library's right or ability to loan or circulate electronic books and digital audiobooks in specified ways. Provides that a person who violates the provisions of the Act commits an unlawful practice within the meaning of the Consumer Fraud and Deceptive Business Practices Act. Effective January 1, 2023." - House Bill 4758 BROADBAND ACCESS ACT "Creates the Illinois Broadband Deployment, Equity, Access, and Affordability Act of 2022. Provides that access to affordable, reliable, highspeed broadband service is essential to full participation in modern life in the State and throughout the United States. Defines terms. Provides that the Department of Commerce and Economic Opportunity shall establish and implement a statewide broadband service grant program. Provides that the Department shall use money from the grant program only for the exclusive purpose of awarding grants to applicants for projects that are limited to the construction and deployment of broadband service into unserved areas in the State and for the Department's cost to administer the program. Provides that the Department shall not award grant money to a governmental entity or educational institution. Provides that the Department shall not, as a condition of an award of grant money, impose an open network architecture requirement, rate regulation, or other term or condition of service that differs from the applicant's terms or conditions of service in its other service areas. Includes provisions providing for the criteria for determining the award of funds, the information an applicant must provide for an application for a grant, the priority by which the Department shall follow in granting awards, and when the Department shall not award a grant to an applicant. Provides that when a grant is awarded, the Department shall provide notice on its website of each application receiving a grant. Provides that the Department shall require an applicant awarded a grant to submit a semi-annual report from the time the applicant receives the grant to 3 years after completion of the project. Makes a conforming change in the Freedom of Information Act. Effective immediately." (https://legiscan.com/IL/bill/HB4758/2021) Filed 1/24/22; Re-referred to Rules Committee 4/11/22.

• SB1828: HAVANA Act of 2021 Helping American Victims Afflicted by Neurological Attacks Act of 2021 [became Public Law No. 117-46 on 10/8/2021]

Specifically authorizes the Central Intelligence Agency, the Department of State, and other agencies to provide payments to agency personnel who incur brain injuries from hostilities while on assignment...Since 2016, some intelligence, diplomatic, and other governmental personnel have reported experiencing unusual cognitive and neurological impairments while on assignment (particularly abroad), the source of which is currently under investigation. Symptoms were first reported by personnel stationed in Cuba and have since been collectively referred to as Havana Syndrome.—posted 11/22/21

- <u>HB5520</u>, Literature Selection Technical Review Committee Reform Act of 2021. To amend the Public Health Service Act to increase due process and transparency at the National Library of Medicine in listing and delisting journals in MEDLINE (or any other current or successor database or indices), and for other purposes. [Introduced 10/8/21]—posted 11/22/21

This bill establishes grants and requires other activities to improve mental and behavioral health among health care providers. Specifically, the Department of Health and Human Services (HHS) must award grants to hospitals, medical professional associations, and other health care entities for programs to promote mental health and resiliency among health care providers. #### BRIEF UPDATE-HSLI LIAISON TO MIDWEST CHAPTER /MLA- Ramune Kubilius

- The state representatives met virtually: Jan 12 & June 27, 2022. State library groups' representatives shared their plans for 2022 that included meetings and virtual events already held, sometimes coordinated with other groups in the respective states. In June, the merits of virtual vs on-site meetings were discused, as were highlights of the 2022 MLA meeting in New Orleans. HSLI news and plans were shared.
- The elected Midwest Chapter/MLA Representative-at-Large moved out of state, so during the second year of the term, Merle Rosenzweig (Michigan) is convening meetings and representing our group at Chapter board meetings & Ramune Kubilius (Illinois) is "scribing"...This continues until the Midwest Chapter /MLA elections are concluded and the new Representative-at-Large /state liaison/ is named. Shown below is the year-by-year number of posts since inception of the online *HSLI Newsletter* in July, 2010. A peak averaging 600 posts a year from 2017 through 2019 was followed by dip in 2020. The dip coincided with the pandemic's effect on activities in the scope of the *Newsletter* content (e.g., conferences, other professional activities). The number of posts in 2021 returned to pre-pandemic levels. At time of this report, it is estimated the total number of posts for 2022 will also approximate the pre-pandemic peak average.


