It expands professional opportunities within a similar structure to HSLI membership for a reasonable cost as well. Membership in Midwest MLA includes rights and privileges exclusive to membership such as professional leadership opportunities or professional development opportunities expanded to a nine state region; knowledge growth or continuing education opportunities at the Midwest chapter annual regional conference; and networking opportunities such as *MIDLINE*, the Chapter newsletter, and *MIDWEST*, the Chapter discussion list and now blog, and the Midwest MLA online membership directory. While Midwest MLA offers the same types of benefits to its members as HSLI, there are additional benefits that I'd like to highlight here.

One is Professional Recognition. Midwest MLA offers two Awards that acknowledge our efforts as Health Science Librarians. These awards described below provide us peer recognition, compensation for our role in enriching our profession and concrete acknowledgement of our satisfaction in our life's work.

Jean Williams Sayre Innovation Award

The Executive Board of the Midwest Chapter established the Award in 2005 to honor individuals, groups, or libraries that have displayed creativity and/or problem solving skills that have resulted in innovative methods, projects, products, organizational enhancements or publications in the field of health information management.

Distinguished Librarian of the Year Award

The Executive Board of the Midwest Chapter established the Award in 2005 to honor a Chapter member who has made outstanding professional contributions impacting librarianship and was awarded for the first time at the 2005 Annual Meeting.

Go Local

In the fall of 2006, Loyola University Health Sciences Library announced its intention to create a “Go-Local” project for Illinois, titled Health-E Illinois. Since this announcement, the Health-E Illinois project team has been busy gathering and inputting information for health service locations throughout Illinois and is pleased to report over 3,000 completed records are now included in the database. To date, most of these records concentrate on senior health topics, emergency preparedness, and drug/substance abuse. The project is on track to go live September 1st of 2007 and will include over 8,000 records.

Despite the advances made, there are still a vast number of unrepresented health service locations. To assure that the database is as comprehensive as possible by the go-live date, the project team is encouraging participation from the health sciences librarians of Illinois. A list of health services that have little or no representation in the database has been published online. Librarians can select a service from this list, find locations that provide that service, and e-mail their findings to the project. In addition, librarians can provide information regarding their institutions for inclusion in the database. Ask Away - Illinois Virtual Reference

Ask?Away is an online reference service developed by the Illinois State Library. Based on OCLC's QuestionPoint reference management service, it provides Illinois Libraries with the tools they need to interact with their users in multiple ways, using email and chat. This statewide, multitype partnership includes public, special, school, medical, college and university librarians working together to offer the broadest possible Internet help service. Medical libraries can form their own group within the cooperative to help answer medical questions and participate in the 24/7/365 cooperative.

The Internet can be difficult to navigate, and good information can be hard to find. Sometimes reliable information is available only from a library resource. Libraries are implementing Internet help desks in response to the ubiquity of online resources and Internet access. Many librarians are providing virtual reference services in addition to telephone, fax or in-person requests for information.

Ask?Away was established in November 2005 and is going strong in Illinois with #230 participating libraries.

During February 2007, #520 email questions and #2,872 chat sessions were conducted.
