This year, a special conference session was held on Wednesday afternoon, called "The Future of Consortia." Ruth Holst, Associate Director NN/LM-GMR, facilitated the session, which was largely an open forum and brainstorming session on what our local health sciences library consortia are doing currently, and what we would like them to be doing in the future. Ruth gave a brief introduction on the history of consortia, and then opened it up to discussion. I was particularly enlightened by the fact that most, if not all, of the participants of the session agreed that there is value in maintaining local consortia, and that the opportunity to meet with colleagues and share knowledge is a key function. Of course, while the session was well attended, many of our colleagues were unable to attend, a point worth noting, since barriers to attendance are an issue for many consortia members. However, this session was a great starting point in looking at those issues and addressing the future of consortia and how they relate to HSLI and health science librarians and libraries. I will be providing a more detailed summary of the session in a future newsletter.

The HSLI Board is also considering future alternatives for coordinating the annual conferences, to help spread the responsibilities beyond the hosting consortium each year. We will seek input from the membership on these alternatives as they are further developed. Professional meetings are such a great opportunity to update knowledge, share experiences, and reconnect with friends. My goal is to find an alternative that will give our current system a shot in the arm, building upon what we are already doing right. In the meantime, the East Central Illinois Consortium is busy planning the 2007 Fall Conference, "In the Know," to be held in Urbana, and the Chicago South Consortium is currently considering a joint conference in 2008 with an adjoining state library group, so stay tuned for further information as it develops.

My goals for the coming year are to finalize the discussion and resolve the annual conference calendar for the next 3-4 years; define HSLI's role and provide support as a key partner in the Go Local Project; and work with Virginia to continue strengthening the consortial group purchases.




Health Sciences Library to Sponsor Health-E Illinois

The Loyola Health Sciences Library has taken the initiative to establish a "Go Local" project for Illinois. Currently 13 other states have initiated similar efforts for their states. The "Go Local" project, called "Health-E Illinois," will provide links from MedlinePlus health topic pages to information about health services throughout the state. These links include Web sites from hospitals, physicians, nursing homes, support groups, health screening providers and many others. You can link directly from each MedlinePlus health topic to services related to that particular topic. For example, if you choose "Health-E Illinois" from the MedlinePlus Breast Cancer page, you will be able to find links to Cancer Clinics, Oncologists, Support Groups, etc. in Illinois.

Key partners who have agreed to support the development of this database include the Alliance Library System, the Council of Illinois Medical School Libraries, the Health Sciences Librarians of Illinois, Illinois AIRS, the Illinois Dept. of Public Health, the Illinois Rural Health Association, Illinois CLICKS!, and the Illinois State Library. Funding support will be available from a variety of sources, primarily the National Library of Medicine.

Loyola project is called Health-E Illinois.

The objectives of *Health-E Illinois* are to:

- 1) Create a high-quality, user-friendly database of health resources and services in Illinois, linked to subjects within MedlinePlus.
- 2) Positively impact the ability of health consumers and practitioners to locate and access health information and related local health resources and services.
- 3) Increase awareness and use of MedlinePlus and *Health-E Illinois*, through strong promotion and outreach efforts with libraries and healthcare organizations throughout the state.
- 4) Engage with other Illinois librarians, health professionals, and organizations to help identify local health resources that should be included in the database and to increase use of *Health-E Illinois* by libraries and health care organizations throughout the state.
- 5) Increase statewide visibility and appreciation of the important role played by Illinois librarians in linking health care consumers and practitioners to the information they need.

A letter of support of the Board of HSLI was written in support of Health-E Illinois. At the November conference, Ruth Holst, Associate Director of the Greater Midwest Region, NN/NLM announced that the Health-E Illinois proposal was approved by the National Library of Medicine. Please join with me in congratulating Dr. Logan Ludwig, Mary Klatt, Tom Bartenfelder, and Eugene Guidice and the rest of their team for their leadership and commitment to improve the access to health and human services in Illinois.

The Health-E Illinois proposal envisions HSLI members to help make connections between health care providers and MedlinePlus information by contributing links to the project, and education and outreach to health professionals and the public. For the initial implementation period, HSLI will have representation on the project committee.

More information will be forthcoming from the Health-E Illinois project team!!

Thank you to the Metropolitan Consortium for their excellent work in planning and hosting the Libraries on the Move conference in Schaumburg. The CE on Patient Safety resources, and library support for Magnet Hospital status were just excellent.

I would like to thank Lynn Bierma of the Illinois State Library, who has assumed the new position of Interlibrary Loan Coordinator following many years in the OCLC services office. Lynn has served as liaison from HSLI to the state library since 1995. Laurie Bartolini is the new liaison.

At the November board meeting, Laurie Bartolini updated the board concerning several ISL programs, especially AskAway, the virtual reference service which they are supporting throughout the state. The state library would like to see a Medical queue, and in fact several HSLI members are participating. However, many hospital librarians are unable to participate in virtual chat reference because of institutional firewalls. However, the academic libraries might consider AskAway, and participating in a virtual reference queue. Hospital librarians could answer questions via email.

The HSLI board has also discussed implementing a blog, moving to a new web site host, and how to plan for state wide meetings in the future. The board OK'd pursuing discussions with the Indiana Health Science Libraries group for a possible joint meeting in 2008. Molly Horio and Karen Douglas did some research on how other state wide groups plan and host their annual conferences. The board will continue to monitor the situation.

Contratulations to our new treasurer Stacey Knight-Davis, and Thank You to Kitty Wrigley for her faithful service these past two years. Also congratulations to Linda Feinburg for her election to the board as President Elect.

I have set two goals for myself for the coming two years as Past-President on the board.



First, I would like to work on grants information projects for those librarians in the state in sharing ideas and best practices of providing grant information and grant writing assistance. I currently am the grants information officer for Governors State, and have established a Grants Information Center in the University Library. There are sources of grant announcements for the state of Illinois which are available for free; and we should be advocates for our hospitals and health professionals we serve to secure sponsorship for their programs and research.

Secondly, I would like to form an HSLI writing/publishing interest group, to support research and publication particularly in hospital librarianship, and other topics of interest to health science librarians. We could have an article in the newsletter on recent publications and presentations of health science librarians in the state. It is good for us to be aware of each other's research and professional activities to learn from each other and disseminate the research of those who are doing research.

It has been my pleasure to serve as HSLI president these past two years. I have grown personally and professionally. I look forward to working with the incoming president, Molly Horio, and I trust you will all give her your full cooperation!
