PRESIDENT'S MESSAGE



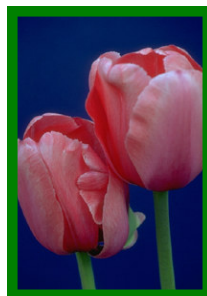

Bylaws Change Passes

At the fall meeting, the bylaws change involving the elimination of the Illinois State Council was discussed. It was proposed that the Illinois State Council be replaced by a single individual to serve as liaison to Networks (Illinois State Library, ILLINET, and NN/LM GMR). This individual would be appointed by the current President to serve a two-year term. 73 ballots were returned. The vote was unanimous in favor of the bylaws change.

New Feature Added to NLM's MEDLINEplus

The National Library of Medicine (NLM) has added a daily news service to their consumer on-line public database, MEDLINEplus.

Every weekday morning the home page of medlineplus.gov will be updated with selected health-related articles from the Associated Press, New York Times Syndicate, and United Press International, with NLM anticipating more sources to be added. Articles will be listed on the home page as well as cross-referenced to one or more of the 430 subject areas listed on MEDLINEplus.

"We realize how important it is for people who search for information on the web... to go to a site they trust," said NLM Director Donald Lindberg. MEDLINEplus draws on the extensive resources of NIH and other reliable, non-commercial sites. No registration is ever required for MEDLINEplus users.
