The holdings have been weeded and combined under the new Libid 62301C, which is Blessing-Rieman College of Nursing & Medical Staff Library, 11th & Broadway, PO Box C3.

Libraries which have 62301B in their Doctype routing should send a memo to the Doctype Coordinator at NN/LM-GMR, asking that their routing cell for 62301B be changed to 62301C. Just that simple!

Libraries which have Blessing programmed into their fax machines should verify that the number is 217-223-6400. There is only one Blessing library now.

The next meeting of the Council will be on October 11, 1994 at 3:30 in the Rockford Clock Tower. This will be a very abbreviated meeting before the HSLI business meeting, and all members of HSLI are invited to attend, as usual.

Items of interest from the NN/LM, GMR:

Janice Kelly has resigned as Associate Director of the Greater Midwest Region effective September 16, 1994. This will mean that a new representative will be appointed to serve as liaison on the Council. A copy of the position available listing for the job is available from GMR.

The GMR is soliciting proposals for a technology awareness program. Funds of up to \$5,000 are available for a program that will introduce or enhance health care practitioners awareness of information technologies. The program must be scheduled between Nov. 1, 1994 - Dec. 31, 1995. RFQ's must be received by the GMR office no later than 4:00 pm on Sept. 9, 1994.
