Approval of Minutes:

The minutes of the June, 1999 Board meeting were approved as read.

Treasurer's Report:

The treasurer's report was approved. The issue of putting some money in CD's was discussed and a report will be presented at the next board meeting. The treasurer presented a report on annual meeting profit and loss. Beginning with the 1999 conference, each chair will be asked to submit a final report with data on income, expenditures, attendance, CEU's, location, and sponsors.

Committee Reports:

Reflections on the Conference in Quincy

The Annual HSLI Conference was held on November 4-5, 1999 at Quincy Holiday Inn in Quincy, IL. The conference's theme was "Embrace the Past & Plan for the Future." Arlis Dittner and her crew organized the conference meticulously. It was, indeed, a time consuming task, and they did a wonderful job organizing all the programs.

On Thursday, November 4, we attended two CE

courses. The first course was "Teaching the Adult Learner" by Carla Morrison. The second was a very constructive course called "Technology Troubleshooting" at the Alliance Library System by Kay Cloyes. We learned the step-by-step basics of technology troubleshooting by using hands-on exercises on the computer. This course was aimed at those who seek help for minor problems that can be taken care of without the help of the Information Service Department. After the CE courses, we took an architectural tour of Quincy. The one hour tour took us to see 19th century homes, as well as other landmarks. With the cooperation of the weather, we were able to observe a beautiful sunset overlooking the Mississippi River. After the tour, we attended a reception at the Gardner Museum of Architecture & Design, another historical site. We all enjoyed the nostalgic displays in the museum, and the historical information provided by the curator.

On Friday, November 5, 1999, Eric Schultz's lecture on "Recognizing Depression" was very engaging. He was able to bring a little humor to the talk, despite the seriousness of the topic. Following the lecture, Kitty Wrigley and Iris Nelson presented a historical panel on librarians and historical research. Ms. Wrigley co-authored Memorial Days: A History of Community Partnership, 1897 - 1997. At the end of the session, she presented 12 copies of her book to audience members; I happened to be one of the lucky ones who received one! The Centennial Celebration 1894- 1994 Poster project, coordinated by Arlis Dittmer and Sharon Wharton, was a historical piece presented for the Blessing Hospital Training School for nurses.

NNLM/GMR's, Jean Sayre, Associate Director, and Lorna Springston, Consumer Health & Outreach Librarian, updated the new Docline system and Consumer Health including Medline Plus. They urged us to check the website for latest information. Our members had a few questions, of which Jean Sayre will follow up on soon.

Jean Wilkins' session was on "The Illinois State Library Today." She highlighted VIC, the Virtual Illinois Catalog of Illinois Library, resources. She advised us to visit the website <http://findit.sos.state.il.us> for governmental and library information. She also reminded us about the HSLI Teleconference, Illinois State Library, on December 15, 1999.

The day concluded with the HSLI Annual Business meeting. At the end of the meeting, Toni Tucker passed the gavel to the president-elect, Jan Perone, to adjourn the meeting. Jan Perone reminded all members to get ready for the HSLI Fall Meeting in Rockford, IL, which will be held on November 9-10, 2000.

ILLINOIS STATE LIBRARY

Report by *Nina Pals*

Jean Wilkins spoke to attendees at the HSLI Conference in Quincy. She expressed her desire to work with HSLI.

Teleconference

The first result of this collaboration will be a teleconference. HSLI will present a consumer health program geared to public and school librarians on December 15. This will be part of the series of teleconferences that the State Library broadcasts on Wednesday of every other month.

Committees

The Illinois State Library recently appointed three committees. *Toni Tucker* from Illinois State University will serve on the *Delivery Committee*. A consultant recently evaluated the state's delivery system. In light of upcoming changes, especially with VIC (Virtual Illinois Catalog) coming online, the consultants recommended no changes, but instead to reevaluate the system in two years.

Kitty Wrigley from St. John's Hospital in Springfield will serve on the *Interlibrary Loan Committee*. This committee will update the interlibrary loan code which has not been revised since 1992. It will also evaluate methods of gathering statistics on interlibrary loans and how to share that data with libraries.

Arlis Dittmer from Blessing Hospital in Quincy will serve on the *Automation/Technology Committee*. This committee will deal with technology issues including the new Illinois Century Network.

Find-It! Illinois

Jean introduced this new Web portal to Illinois government and library information. Its purpose is to increase access to information for Illinois citizens. Resources on it include VIC - databases of all 12 library systems searchable in various combinations, IGI - the Illinois government information Websites, and First

Search. (SEE Toni's column under "Library Systems")

Project Next Generation

This demonstration project is for young people, some of whom may have problems with school or the law. It will be sponsored through public libraries in nine communities. It involves working with young people by providing mentoring and technology tutoring.

Legislative Issues

The State Library is working with ILA to increase the equalization rate for libraries. It is also working on funding for the Illinois Information Initiative to provide a permanent source of funding for technology, i.e. the new backbone Illinois Century Network, and LANs and computer equipment in libraries.

Literacy

The Secretary of State's Office spends \$7-8 million dollars annually on literacy. In the thinking phase is partnering with the medical community for literacy. This might include helping people who speak another language or with a low reading level to understand their diagnosis, tests, or prescription information.

Jesse White Fellow Program

This involves recruitment of minority librarians to 2-3 year positions at the ISL to gain experience.

Jean asked all of us to recruit people to the library field. Many librarians will be retiring in the next few years. Last year the ISL provided 16 grants of \$7500 for individuals to attend library school (can be an out-of-state school). Persons receiving the grants must agree to work in an Illinois public library or the ISL after completing their degree.

INTERNET

Internet X 3

Do you feel comfortable and competent on the current Internet? Good! Then you are ready for the next generation. There are two projects currently under way to promote the development of the next generation infrastructure and the next generation of network applications for internets.

Internet2

Internet2 started in 1996 to develop an "unclogged" research network. It currently has 160 member universities plus corporate and federal

government partners. Members pledge from \$500,000 to \$1,000,000 annually. Network applications under development include distance learning, digital libraries, video teleconferencing, and virtual laboratories. The first connections, the Abilene network, were rolled out in February, 1999 between thirty-seven universities.

Next Generation Internet (NGI)

This project is a complement to Internet 2. The key difference is NGI's focus on the needs of federal agencies (National Science Foundation, the Defense Department, NASA, the National Institute of Health, etc.). The federal government announced NGI in 1997 with a \$300 million commitment over three years. Its next generation applications include telemedicine and health care, national security (star wars?), energy research, environmental monitoring and manufacturing.

Both projects have the development of a super-high-speed infrastructure to support current and new applications that the current Internet is too slow to support. We are talking gigabits (G/bps) as opposed to the kilobytes (K/bps) that data travels on the current Internet. According to my calculations, data will travel one or more million times faster on the next two Internets.

What does this mean for current Internet users? The movement of university research projects and government applications to the new Internets should speed up the current Internet. While the new Internets are not being designed for public use, most likely they will migrate to commercial and public use as did their predecessor. Can you imagine the possibilities?

LIBRARY SYSTEMS

FIND-IT! ILLINOIS

At ILA in October Jessie White unveiled the new web site *Find-It! Illinois*. On November 3rd the Illinois State Library held a satellite teleconference describing what exactly *Find-It! Illinois* will do for your library. It is described as "Your portal to Illinois governmental and library information on the Web!" *Find-It! Illinois* brings together Illinois Government Information, FirstSearch, and VIC (Virtual Illinois Catalog).

Illinois Government Information provides access to

State of Illinois Web pages in one location. By word matching and subject category browsing in the same search site, IGI will give users improved results in finding government information.

• FirstSearch is the FirstSearch Basics offered by the Illinois State Library across the state. You may access from this point using your library's FirstSearch authorization and password.

• Virtual Illinois Catalog, otherwise known as VIC, is the one site from which you can search the holdings of 600 libraries in the state of Illinois. For the first time Illinois residents have access to millions of items in Illinois Libraries. VIC is accessible from any computer that has Internet access. Eleven of the twelve library systems in the state have provided their holdings for this project along with Illinet Online (DRA System). VIC is still in its beginning stages, so there are still many bugs to be worked out along the way.

NNLM / GMR

Report by *Nina Pals*

Jean Sayre, Associate Director of GMR, provided an update on NLM projects at the HSLI Conference in Quincy.

DOCLINE

The new DOCLINE system is scheduled for release on February 12, 2000. This date is subject to change.

During the week of February 7-11, 2000, all users can update their DOCUSER and SERHOLD records in the new system.

NLM has developed a new test site at: www.nlm.nih.gov/docline/test. Librarians are encouraged to visit this site and ensure their browsers work with the system.

A major snag to interacting with the new DOCLINE may be hospitals' firewalls. If your firewall does not allow information in from the Internet except from approved IP addresses, you may not be able to interact with DOCLINE. GMR staff will check this and respond to the issue, including providing DOCLINE's IP address as needed. If you have a modem and a dial-access

Internet provider, there should not be a problem.

PubMed Central

This NIH-operated site will be unveiled January 1, 2000. It will provide electronic distribution of life science research reports.

PubMed Central will archive, organize, and distribute peer-reviewed reports from journals, as well as reports that have been screened but not formally peer-reviewed by independent organizations. Non-peer reviewed material will be clearly distinguishable from the peer-reviewed content of PubMed Central. The Web address is:

Multiple Congenital Anomaly/Mental Retardation Resource

At present this system includes structured descriptions of 700 out of 1600-2000 syndromes of congenital abnormalities known to be associated with mental retardation. The Web address is

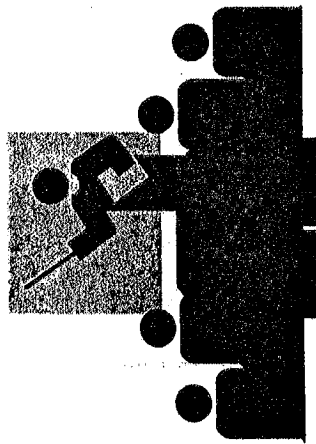

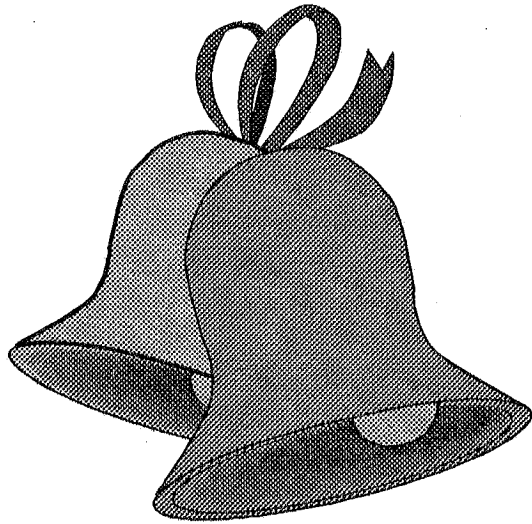
