Our experiment with using Serhold for the serials holdings list had mixed results. The holdings information is current and the price is right (free!), but HSLI volunteers spent many hours editing the document. It was too large to download into Word while retaining the formatting you see in the Docline web site report format. Now that NLM and OCLC are able to exchange data, we may return to an OCLC-generated list.

We are working with 4 vendors for our group purchase (Ovid, MDConsult, Gale Research, and Ebsco), with a target date of June 1 for vendor proposals. This will enable members to select from a menu of products for the mix that meets their needs and their budgets. I was pleased to learn that more libraries had budgeted for these products this year. Spreading the costs among more participants should decrease the costs for the individual library.

A future project HSLI is considering is participation in the MedlinePlus Go Local initiative in conjunction with ILLI-NOIS Clicks. There are many issues to consider, with the most significant being the NLM requirement for a project coordinator, but no funding to pay a project coordinator. This may take more time than a volunteer is willing or able to give. We are working with the ILLINOIS Clicks staff to determine how we use and can expand our existing database. There are also plans to add more topics to the health section. We welcome suggestions for additional topics, especially if the suggestions are accompanied by a volunteer to research and input sites. It's actually a very easy process.

Prepare yourself for another bylaws change. There are many sections that need updating. It is absolutely essential that we modernize the process of updating the bylaws now that HSLI has only one conference and one business meeting per year, and now that we have more options for communicating with members. We plan to hold a short business meeting at this year's joint conference in Springfield to meet the current requirement of presenting a bylaws change to the membership at the annual business meeting. It won't be the usual luncheon meeting, just a short meeting tucked in between the many interesting sessions planned by our creative program and CE planning committees.

I hope to see all of you in Springfield in October!

### **ILLINET Group Services**

Starting in FY05, ILLINET/OCLC Services will move to a new pricing module, called ILLINET Group Services. Instead of transaction based OCLC pricing, libraries will receive a set price for FY05, FY06 and FY07. We've had meetings in April and May at each of the library systems to let our membership know of the change and explain exactly what it means for ILLINET libraries. Below you'll find a summary of the changes.

### **ILLINET/OCLC Group Services**

### What it Means for Illinois Libraries

## Access to SILC: the Statewide Illinois Library Catalog (http://www.finditillinois.org)

- Unites Illinois holdings with ILL Capability in a single statewide union catalog.
- Based on the familiar FirstSearch platform.
- Unlimited use.
- Unlimited ILL.
- · Connect charges included.
- ILDS & intra-system delivery still available.
- Shelf status: links from individual libraries to their regional library system's shared online catalog (LLSAP).
- Links to LLSASP records from the WorldCat OCLC accession number.

### **Access to Suite of OCLC Services**

- Unlimited use of cataloging, ILL and serials union listing.
- Bibliographic record notification.
- Electronic delivery of records.
- Catalog cards.
- Telecommunications included.

#### **Benefits**

- Known price for each of the next three years: FY05, FY06, FY07.
- Single annual bill; option of multiple payments throughout the fiscal year.
- Enhanced resource sharing options.
- Quality cataloging.
- Ability to implement retrospective conversion projects.
- FirstSearch Base Package continued to be provided by IL State Library.

### Requirements and Responsibilities

- Full (not developmental) regional library system membership.
- Contribution of all current cataloging to WorldCat.
- Compliance with the OCLC Principles of Cooperation.
- Responding to messages in the OCLC ILL Message File.

### Eligibility

• All ILLINET libraries that are full (not developmental) regional library system members.

### **Pricing**

- Existing users: a baseline was established by looking at activity on product codes that are covered under Group Services, and performed from December 2002 through November 2003. Credit activity included in established baseline.
- Percentage included for normal OCLC price increases:
  - o FY05-Baseline plus 5%
  - o FY06=FY05 total plus 5%
  - o FY07=FY06 total plus 5%
- New users: discounted pricing for the first three years; based on materials budget. FYO8 and beyond:
  - o Fee structure reestablished for al libraries.
  - Includes materials budget, service population and consideration for original cataloging and ILL lending.

### **Existing User**

(if you fall within one of these 3 categories)

- Libraries that uses OCLC for cataloging, ILL or union list.
- Libraries whose regional library system performed cataloging, union list or ILL work on their behalf.

## Partnering for Patient Education Grant Follow-up

In October, 2003, the OSF Saint Francis Medical Center Library & Resource Center was awarded a \$60,000 LSTA grant from the Illinois State Library for the "Partnering for Patient Education" project. With this grant, the Library will be working collaboratively with Patient Care Services and Education & Development to redesign the patient education process, as well as pilot the use of tablet pcs and interactive tutorials on 8 nursing units. The grant website is http://patiented.osfsaintfrancis.org . Elements of the project include using the Library's catalog to create a centralized database of patient education materials, developing a website for online access to resources, creating educational tutorials that will be available through Healthstream, and promoting the use of the Patient Education Interactive tutorials as an alternative format to print. While the grant project ends June 30th, the Library's involvement continues with ongoing development of the catalog, website, and piloting of the tablet pcs.

## **HSLI Conference \$cholarship\$**

This year there is a joint regional conference of the Midwest Chapter of the Medical Library Association and HSLI. The theme is <u>The Road to Collaboration</u>. The conference will be October 9-12, in Springfield at the Renaissance Hotel.

The HSLI Board voted last fall to offer several scholarship stipends to its members so that everyone would have the opportunity to attend a regional conference.

### Applicants must:

- be HSLI members with 2004 dues (\$10) paid in full\*
- submit a completed application by August 20, 2004 (to include a short essay explaining the need for a scholarship)

There are several different types of scholarship stipends being offered this year:

- Syed Maghrabi Scholarship stipends for conference registration + hotel room (if you live more than 50 miles from Springfield) (this year only: conference registration, excludes separately priced CE's)
- 2 Conference Registration Scholarships (only covers conference, not CE courses)
- 2 Continuing Education Course Scholarships (each good for 1 full-day CE course or 2 half-day CE courses, not conference registration)
- 2 Student Conference Registration Scholarships\*
   (1 each, available to students currently enrolled in a MLS or LTA program in Illinois)

\*Student applicant need not be an IL resident or HSLI member

Applications will be available on the HSLI web site (http://hsli.org) from August 2-August 20, 2004. Applications must be postmarked by August 20, 2004 for consideration.

Those receiving scholarships will be notified by September 1, 2004. Conference room rates of \$82.00 per night (1-4 occupancy) include parking fees and expire September 15, 2004.

Members receiving scholarship stipends will be asked to write a short article about their conference experience for the next edition of the HSLI Newsletter.

### STIPENDS AND CRITERIA FOR APPLICATION

### 1. Syed Maghrabi Scholarship

- The stipend will cover the registration fee for the conference, excluding any separately priced continuing education courses.
- The stipend will cover the cost of a standard double room at the conference hotel if the recipient's home is more than 50 miles from the conference location. The recipient will pay for the hotel, and will be reimbursed upon submission of expense report to HSLI treasurer and article to HSLI newsletter.
- Applicants must be current (2004 dues paid) HSLI members.

### 2. Conference Only Stipend

- 2 stipends will be awarded.
- Stipends will cover full conference registration fee, excluding any separately priced continuing education courses.
- Applicants must be current (2004 dues paid) HSLI members.

### 3. Continuing Education Course Stipend

- 2 stipends will be awarded.
- Each recipient may choose either 1 full-day CE course or 2 half-day CE courses.
- Applicants must be current (2004 dues paid) HSLI members.

### 4. Library Student Conference Only Stipends

- 2 stipends will be awarded.
  - 1. One stipend will be awarded to a student currently enrolled in an LTA program in an Illinois LTA program.
  - 2. One stipend will be awarded to a student currently enrolled in a master's degree or higher program in an Illinois library school.
- Stipends will cover full conference registration fee, excluding any separately priced continuing education courses.
- Applicants need not be current HSLI members.
- Applicants need not be Illinois residents, but must be enrolled in an Illinois LTA program or library school.
