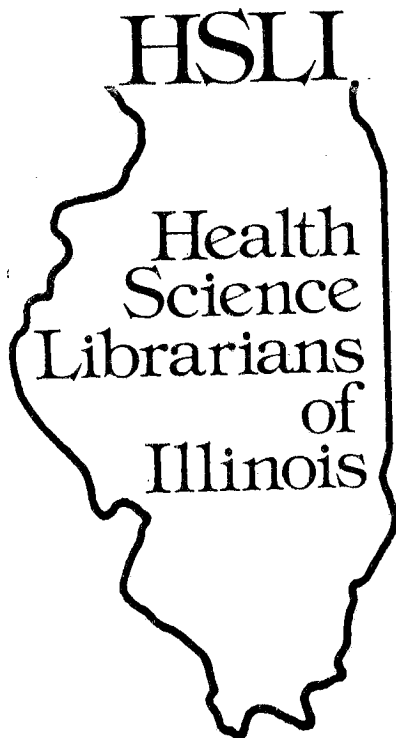

**ILLINOIS STATE COUNCIL Report**

The Illinois State Council met March 19, 1993 in Matteson, IL from 7:30am - 9:00am. Topics discussed:

- \* Suzanne Schiar announced that changes in Prism would be in effect starting April 17, 1993. Some of these changes include keyword searching and change in cost structure. There is now an Interlibrary Loan link between OCLC ILL and FirstSearch's Reference Database.
- \* LVIS (the OCLC GAC for non-charging libraries in Illinois and Missouri) will be accepting new members January and July each year. The cost will be \$25 for profiling if you are already a member of any other GAC.
- \* A State Teleconference on INTERNET was held March 24, 1993 from 10-12. A copy of the tape has been sent to each library system and should be available for loan.
- \* Janice Kelly is the new Associate Director of the Greater Midwest Region. She presented the report from the GMR office. She mentioned the Outreach Grants from.nlm, and that.nlm will be trying to market Grateful Med through medical book stores.

Our attempt to elect a health science library representative to the ILLINET/OCLC Steering Committee did not succeed this year. We will try again at their next election.

The Council voted by fax after the last meeting (Jan. 15, 1993) to recommend changes to the HSLI Bylaws. These changes have gone to the Executive Board of HSLI. Nancy Stump, Chair, appointed a task force headed by Jan Perone, Bylaws Chair, to provide recommendations for overall Bylaws changes. We were particularly interested in membership status (personal and institutional), and how that effected the Council membership.
