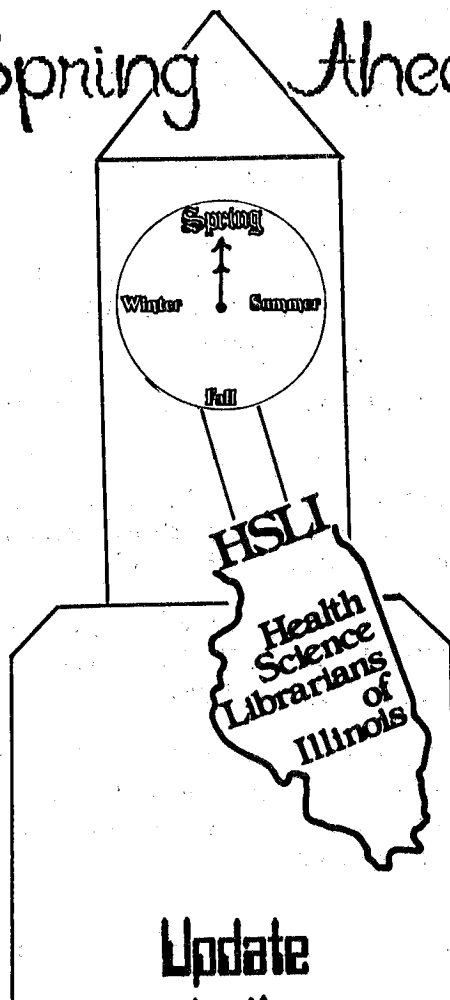

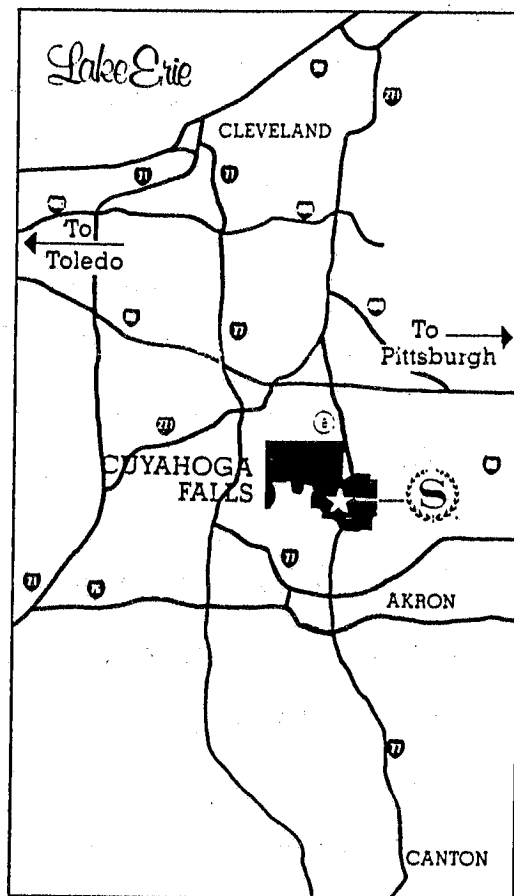

RE: Preston Levi Resignation

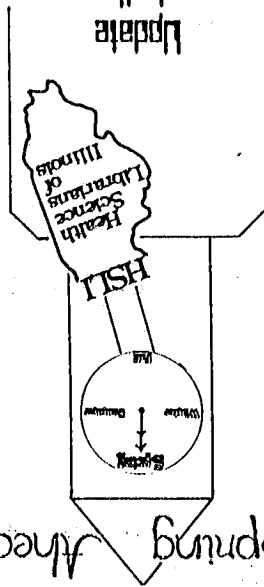
Preston Levi, Assistant Director for Library Development, has submitted his resignation from the State Library effective April 15, 1991. During his ten years on the library staff, Mr. Levi has been an outstanding and articulate voice for library cooperation, preservation and rural libraries in particular.

Our successes in interlibrary cooperation programs-the statewide delivery system; cooperative collection management; cooperative preservation; the library telefacsimile network; ILLINET interlibrary loan studies, protocols and procedures; school/public library cooperation - all were greatly influenced by Preston Levi. His concern for "the kids" and rural libraries is notable.

Mr. Levi has no immediate library plans although he talks of returning to the south (Florida or Louisiana, perhaps) - not a southern Illinois library system although we did lure him away from the Shawnee Library System!
