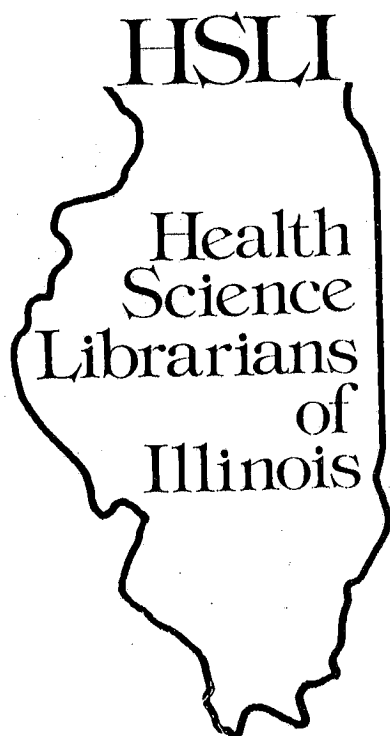

ILLINOIS STATE COUNCIL Report

The Illinois State Council met on January 14, 1994 at Marianjoy Rehabilitation Center in Wheaton.

After heated debate/discussion on various methods of combining the Council and the HSLI Board, a motion was moved and passed to continue recommending the previous by-laws change requests, thus keeping the Council intact. The Representatives on the Council are to represent the groups of consortia members, resource libraries and non-aligned (all other) health science libraries in the state, not the Institutional membership of HSLI. In the future we will ask the nominating committee to recommend consortia representatives on the basis of which consortia not are already directly represented so that there will be less overlap and more direct communication. This decision was reached after perusal of the Council Fact Sheet, HSLI Bylaws, and the other 10 Regional State Council's structures as they are now, will be, or have been. It was brought up that many of the Council members felt they have benefited by having separate meetings which enhance the communication between libraries that are members of consortia, resource libraries, all other health science libraries in the state, the GMR office, and the State Library. The Council felt that this is of continuing importance, and shouldn't be confused with the HSLI Executive Board's function of running the organization and meetings. I would like to thank guests Gerald Dujsik and Walter Wilkins, Bylaws chair, who contributed greatly to the discussion.

Other information disseminated at the Council meeting were:

- * Janice Kelly from the GMR asked for contributions for the 3-Sources about specific examples of uses of Internet by your library that might be of interest to other libraries to justify Internet charges to administrators.
- * Lynn Bierma from the State Library reported on the SILO list. The State will order the next (1995) SILO printout and pay for 50 copies but we (libraries who order it) will have to pay the processing fee of approximately \$2,000. After this order the State will order the printout if we would like them to, but will not pay for processing or copies. Also mentioned where the Statewide Library Card program - only interested libraries need to participate, we will be receiving more information on this in the near future. Ally grants are available through the Library Systems that will provide computers with CD Rom. For more information on them call Barb Allen (217)524-0772 or Jean Wilkins (217)785-1534.
